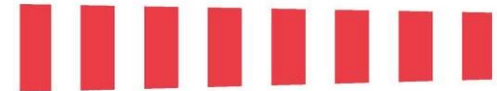
Don't Think of a Killer Robot..

So, what has this got to do with the panel?

Framing the Debate..

- The good news is that we are finally dominating the news waves;
- The worrisome news is that much of the coverage is being framed in terms of how to stop the Evil AI rather than about the many benefits of AI.
 - I realize some of this is certainly because of the overzealous reporting—but we could also do a better job.
 - ..and lord knows we have been a bit starved for public attention since the heyday of expert systems
 - I mean the whiplash inducing jerk with which popular opinion went from “AI is a dud” to “AI is going to take over” is something to behold
- But this is certainly starting to have some unexpected consequences. I have heard an federal program manager tell me that they are being asked to be careful about mention AI in senate testimonies etc.
- I think we need to take better lead in **framing the public discourse** on AI.
 - We are currently following rather than taking the lead..
 - We should resist

Theme of IJCAI 2016

Human-Aware AI



- It is important that we focus on emphasizing the societal benefits of AI before dwelling on the possible safety/security issues
 - There is of course a lot we can do, and are doing—AAAI openhouse for example
- This is why, for IJCAI 2016 next year, we are going to have “Human-Aware AI” as the special theme
 - While I probably could have gone with a “Stopping Evil AI” special track, and raised a lot of sponsorship and attention, we decided to chose this more general theme
 - chose this specifically to highlight the many positive interactions AI systems will continue to have in cohabiting with humans
 - Including human-robot teaming,
 - human-in-the-loop decision support systems,
 - Human-machine collaboration (embodied or virtual)
 - It also pushes the frontiers of AI research in many interesting ways—including those who have drifted to human factors etc

On Defragmenting AI

- In IJCAI 2016, we will be going back to a single main-track
 - No horizontal special tracks such as “Planning” track, “Learning” track, “KR” track etc.
- Rationale: If we steadfastly stick to our own silos even at IJCAI, when will get to focus on integrated AI?
